The main terms of the grant are mentioned below:

1. **Grant Price: Rs. <u>843.20</u>** per share (Close Price on NSE on Tuesday, July 22, 2025, viz., previous trading day's Close Price at the Stock Exchange having the highest trading volume).

- 2. **Vesting Period:** 3 years from date of grant, spread at 33%, 33% and 34% at the intervals of one year from the date of grant.
- 3. Exercise Period: 5 years from date of vesting.
